Building Inspector

- The Village of Plandome informed the Building Inspector that Stasi Brothers Inc. illegally dumped the debris from sweeping our roads behind the Plandome parking lot. The company has been issued a summons and the debris has since been removed.
- The Building Inspector has reached out the residents who will be impacted by the jogging path along Stonytown Road. The Village would like to install a new sidewalk as in front of two homes on the south side of Stonytown Road as part of the jogging path, and the homeowners have no objections.
- The Building Inspector presented the Board with an estimate from Barrett, Bonacci & Van Weele, P.C., to stake out the property line along Stonytown Road so the Village Engineer can start the jogging path design.
