## Village Clerk

- The roads seems to be in better shape than last year with respect to potholes. Once the winter comes to an end Mr. Rockelein will evaluate and compile a list of road repairs that will be needed in the spring.

## **Village Attorney**

- Ms. Scelfo presented the Board with proposed legislation to address the short term rental issue that they discussed at the January meeting. The legislation is similar to the Village of Plandome's. She will present the local again at the March meeting for a second reading.
- Ms. Scelfo presented the Board with the EEOC Conciliation Agreement regarding the Port Washington Fire Department as part of the LOSAP agreement. This agreement has been agreed upon by all the Village Attorneys involved in this case.
