# Village Clerk

Village Clerk Randi Malman revisited the topic of National Grid submitting a bond to cover ten street opening permits, which was discussed at the March meeting. The Clerk spoke with other Villages in the area that have similar arrangements with National Grid and no one has encountered any problems. In most cases National Grid will come out and repair a road patch themselves and none of the Villages questioned have ever had to use the bond to make repairs.

Trustee Clinton made a motion that the Board of Trustees allow Nation Grid to submit a \$35,000 bond to cover 10 road opening permits in lieu of individual deposits for each permit. The motion was seconded by Trustee DeSousa.

# **Building Inspector**

Building Inspector Ed Butt spoke with the Village Engineer, John Waltz of Sidney Bowne, about taking sampled of Circle Drive and the other roads in that area to determine the condition of the road before repaving begins. John felt that pavement cores and test holes would be appropriate in order to assess the condition of the subsoil.

# **Code Enforcement/ Deputy Road Commissioner**

- we would need replacement of all as damage was beyond repair

# Circle Dr. - Colonial Dr. Roadway condition

Some potholes unrelated to the water district trenching are starting to grow along these roads (as well as the rest of the Village). The trenched / repaired areas are also starting to fall victim to the freeze/thaw of the last few

weeks. Other Village roads pothole's will be marked out for estimates and bids, and if the Circle Dr. repave is going to be a ways off, do we want Bob to patch the unrelated areas there, and recall the water district contractor to repair (again) the areas related to their project?

# Property maintenance, 190 Bayview Rd.

A Notice of Violation-Order to Remedy was prepared and will be given to the current property owner, noting the conditions requiring remediation, and the applicable Village Code sections. Photos have been taken to document all violations. If the violations are not corrected, a summons(s) will be issued.

# Mayor

- The grant paperwork for the Circle Drive Repaving Project and the Triangle Improvements has been submitted to DANSY.
- Representatives from the DEC, the Town of North Hempstead and neighboring villages met to discuss the Town's Solid Waste Management Program. The DEC is going to create a form for the 9 Villages that have opted out of TONH's plan and would like to create their own. One of the reasons the Villages have opted out is because the Town's tipping fees are extremely high. The DEC does not see an issue with Villages having their own plans.
