**MINUTES**

**Call to Order**

**Present:** Mayor Barbara Donno, Trustees Tony DeSousa and Patricia O’Neill, and Village Clerk Randi Malman.

Mayor Donno opened the meeting at 9:00 AM with the Pledge of Allegiance & verification of a quorum.

**Public Hearing**

Trustee DeSousa made a motion that the Board of Trustees open the public hearing on proposed Local Law No. 1 of 2018 amending Chapter 225 of the Code of the Incorporated Village of Plandome Manor by extending a moratorium previously adopted on June 20, 2017 by Local Law No. 3 of 2017 to temporarily prohibit the construction of any wireless telecommunications towers or facilities and/or prohibit the addition of new wireless telecommunications facilities to existing infrastructure in the Village of Plandome Manor, unless in conformance with the provisions of this article, for a period of one hundred twenty (120) days. The motion was seconded by Trustee O’Neill.

- Nassau County Planning Commission passed a resolution of local determination on March 8, 2018.
- Proposed moratorium is a Type II Action pursuant to SEQRA, which means that SEQRA does not apply to the enactment of moratoria [6 NYCRR section 617.5(c)(30)].
