

PLANDOME MANOR ABSENTEE BALLOT APPLICATION

IMPORTANT: THIS IS NOT A VOTER REGISTRATION FORM. YOU MUST BE REGISTERED.

If you wish to have your absentee ballot sent to you BY MAIL this application must be submitted to the Clerk by March 9, 2021. To receive an absentee ballot in person, this application must be personally delivered to the Clerk no later than the day before the election (March 15, 2021). The ballot itself must be received by the Clerk before polls close on the day of the election.
