Trustee O'Neill asked Mr. Dunn what the number of lumens were from the streetlight, in which Mr. Dunn responded by stating he did not have that information. Mr. Dunn reiterated several times that the streetlight is affecting his family's quality of life. In conclusion, Mr. Dunn requested that Board consider moving the location of the streetlight. Village Engineer

The Village Engineer, James Antonelli, updated the Board on the following items:

The Village Engineer presented to the Board the bid results for the repair of Gristmill Lane and Papermill Road and portion of Rock Hollow Road. The engineer provided the Board with his recommendation for awarding the contract.

Village Treasurer

The Village Treasurer updated the Board on the following items:

- Treasurer, Marie DePalo, provided the report on the Abstract Report of Audited Vouchers and the Profit and Loss Statement.
- The Treasurer presented the Government Crime Policy to be renewed.
- The Treasurer presented the Village Capital Asset Policy.

Village Clerk

The Village Clerk updated the Board on the following items:

- The Clerk reported that the Nassau County CPR Guardrail project for the guardrail on North Plandome Road was approved by the Nassau County Legislature on September 18 during the county's legislative session. The Clerk added that the village will receive the fully executed contract from Nassau County in the coming weeks and upon receipt, the village can begin the project.
- The Clerk reported that the Tax Lien Sale bill has based both the senate and the assembly and was signed by the governor.
- The Clerk mentioned that many of the street name signs in the Village are in need of the replacement. The Clerk reported that she and the Building Inspector have evaluated the street name signs in the Village and have imputed the data into the new Village GIS map. She also mentioned that she is in the process of collecting and analyzing all the data and researching placement options.
- The Clerk provided the Board with an image of a fire hydrant logo to be painted on the streets as the Manhasset Lakeville Fire Department has proposed. Upon discussion, the Board has stated that the hydrant street painting is not need in the village.
- The Clerk presented and discussed with the Board a resolution to amend Chapter A228-1. 'Schedule of Fees.' The Clerk provided a comparison of the existing and proposed fees.
- The Clerk presented the Firefly Admin engagement letter for the Port Washington Fire Department Service Award Program. She mentioned that the engagement would be fore a two-year period starting January 1, 2024, and expiring December 31, 2025.
- The Clerk presented the block party application submitted by Laure Ozner for a block party on Colonial Drive on October 14th, 2023 with a rain date of October 15th, 2023.
- The Clerk mentioned that the sprinklers at the triangle on Plandome Road and Stonytown Road would be winterized between October 16th to October 27th.
