Resolution Authorizing the Home Rule Request:

VILLAGE OF PLANDOME MANOR BOARD OF TRUSTEES
RESOLUTION AUTHORIZING HOME RULE REQUEST

WHEREAS, the Board of Trustees of the Incorporated Village of Plandome Manor, Nassau County, New York does not have authority under New York State Law to enter into contracts to sell, or pledge as collateral for a loan, delinquent real property tax liens;

WHEREAS, the Board of Trustees this authority is necessary to insure the collection of tax revenue;

WHEREAS, the Board of Trustees is required to submit a Home Rule request to the New York State Senate and New York State Assembly requesting that they grant the Village of Plandome Manor the authority to enter into contracts to sell, or pledge as collateral for a loan, delinquent real property tax liens;

NOW, THEREFORE be it,

WHEREAS, such legislation is presently pending in the form of Senate Bill No. S.8201-A and Assembly Bill No. A.8687;

RESOLVED, that the Village Clerk is authorized to submit a “Home Rule Request” to the New York State Senate and the New York State Assembly, in connection with a proposed special law, Senate Bill No. S.8201-A and Assembly Bill No. A.8687, that would enable the Village of Plandome Manor to enter into contracts to sell, or pledge as collateral for a loan, delinquent real property tax liens.
